

EMS Academy

Section 6.01 UNIFORMS

- A. All trainees are to report to class in the prescribed Academy uniform.
- B. Uniforms shall be worn during all class times, during lunch, and while attending official Academy functions.
- C. Uniforms are not required at the beginning and end of each day while going to or from the changing facilities. A complete uniform must be donned by the trainee's arrival into the classroom.
- D. All uniforms are to be clean, neatly pressed, and maintained in a presentable appearance for inspection.
- E. The uniform of the day can be modified at any time for weather or special circumstances. The general uniform standards fall into three classes:
 - 1. Class "A"- Full uniform with all equipment.
 - 2. Class "B"- Same as Class "A", but without collared uniform shirt.
 - 3. Class "C"- Physical training attire (PT gear).
- F. All uniforms and equipment must be marked in such a manner that each individual trainee can recognize their own equipment if mixed with other similar items.

UNIFORM SPECIFICATIONS

- A. **SHIRT** – Shirts may be long or short sleeve, military creases sewn in, blue epaulets and scallop flap pockets on the right and left chest. Shirts shall be cleaned and pressed. Buttons shall be fastened except for top shirt button.

- B. **PATCH** – An approved SRJC/PSTC EMS Academy patch shall be sewn on the left sleeve 1/2” from the seam at the top of the sleeve in such a manner that the patch is level when the trainee at attention wears the shirt.

- C. **PANTS** – Navy of the approved style. Pants shall be hemmed at an appropriate length (no more than two full breaks in the pants leg when the trainee is standing), in addition to being cleaned and pressed.

- D. **BELT** – Belt is to be leather black in color, basket weave finish 1 ¼ -2" in width, with plain silver uniform buckle. Belts are to worn within the belt loops.

- E. **BOOTS**- Boots are to be black in color, made of polishable material. Boots shall be polished at all times. They are to be heavy-duty lace or zip type work or public safety boot with non-slip soles and heels. They shall provide firm ankle support and shall measure not less than six inches in height when measured from the bottom of the heel. Boots shall meet the requirements and specifications in the American National Standard for Men's Safety - Toe Footwear (Z41.1-1967, or current recommendation) and meet or exceed ANSI/Standards (Z41 PT 83MI/75C/75 or current recommendation).

- F. **CAP (optional)** – Approved navy blue baseball style cap SRJC/PSTC logo displayed on the front. Cap is worn for only approved outdoor activities.

- G. **UNDERSHIRTS** – Navy blue EMS Academy crew-neck T-shirt. No frayed, discolored, torn or damaged shirts will be allowed. Long-sleeved navy blue crew neck or turtleneck shirts may be worn under the long sleeve uniform shirt. The long-sleeve and turtleneck shirt are optional.

- H. **PHYSICAL TRAINING T-SHIRT & SHORTS** – Navy blue EMS Academy T-shirt with SRJC/PSTC EMS Training Program logo. T-shirt shall have trainee’s last name on front and “EMS Academy” on back. Navy blue shorts are to be of same shade and material of above-mentioned T-shirt, but do not require logo. Shorts shall not be shorter than mid-thigh. This is measured with arms straight at sides with fingers extended. The bottom of shorts shall be at or below fingertips.
- I. **SWEAT PANTS** – Navy blue sweatpants.
- J. **SWEAT SHIRT** – Navy blue sweatshirt with trainee’s last name on front and “EMS Academy” on back.
- K. **WORKOUT FOOTWEAR** – Athletic shoe with white socks.
