



## PURPOSE

To ensure a safe, professional and consistent academy environment for all students, the Public Safety Training Center (PSTC) policy requires that all students enrolled in EMC programs adhere to the specified dress code of their respective discipline.

### **UNIFORM POLICY**

Students will be responsible to maintain a manner of dress that is professional, clean, orderly and in accordance with this policy. Uniforms shall be worn during all PSTC activities. SRJC does not discriminate based on religion, race, gender, color, national origin, age, mental or physical disability, sexual orientation, or the perception that a person has one or more of those characteristics.

## **Required:**

<u>Shirt</u>: Dark navy blue color, polo style, with no logos or emblems. This is a men's example. This is a woman's example. Shirt must not be frayed, discolored, torn or damaged, and tucked in.

<u>Pants</u>: Regular fit dark navy blue pants, straight leg, 4 or 5 pocket (not cargo). This is a men's example. This is a woman's example. Pants must not be frayed, discolored, torn or damaged. Denim or athletic style pants are not allowed. Pants are to be worn at the waist, of the correct size, and cuffs covering the back of the shoe/boot without touching the ground.

Belt: Black, 1- 2 <sup>1</sup>/<sub>2</sub> inch wide, leather, plain, silver buckle.

Socks: Navy blue or black color that cover above the ankle.

Shoes: Black or dark closed toe shoes or boots, no contrasting colors.

Wristwatch: capable of tracking seconds (digital or sweep hand).

We do NOT recommend purchasing EMT uniforms at this time.

#### **Optional**:

- Undershirt, either white or dark navy blue
- Dark navy blue baseball cap, no logos or emblems.
- Light jacket, dark navy blue, no logos or emblems.
- Dark navy pullover sweatshirt, no hood, logos or emblems.

## **GROOMING POLICY**

<u>Hygiene</u> - All students are required to maintain proper personal hygiene. Fingernails should be kept short, neat and trimmed at all times. Dirty fingernails, bad breath, body odor, dirty or unkempt hair, unshaven or poorly shaven faces are all conditions that do not meet program standards. No visible tattoos shall be allowed at any time.

 $\underline{\text{Hair}}$  – Hair below shoulder length will be confined so as not to fall forward over the face or otherwise endanger the student while working. Hair color shall be a single naturally occurring shade. No decorative patterns shall be cut into the hair.

Facial Hair - Neatly trimmed mustaches and goatees of a conservative nature are acceptable.

<u>Jewelry</u> - No jewelry, except wedding rings and watches will be permitted. No earrings or other visible body jewelry is to be worn at any time while on campus or involved in PSTC related activities.

Makeup - Make-up must be kept subdued and at a minimum.

<u>Body Art</u> - No exposed tattoos to the face. Visible tattoos elsewhere must be covered with fleshcolored bandages or black arm sleeves during class activities.

# **COMPLIANCE POLICY**

Students who do not comply with the above standards will receive a written notice upon the first violation. Second and subsequent violations shall result in dismissal from class that session. Attendance hours lost because of dismissals shall apply to the maximum 6 hours allowed.
