

Requirements for EMC 103 Business Day

Requirement Name	Requirement Description
CPR Certification	Must be the American Heart Association Healthcare Provider (HCP) "BLS Provider". Copy of printed cards must be both the front and back of the card and the back must be signed. AHA eCPR cards do not require a signature.
Drug Screen Cost: \$30*	Drug Screens are completed using Castle Branch. Understand that although cannabinoid metabolites (marijuana) is legal in the state of California, it is not federally. All medical agencies operate under federal regulations. You cannot attend EMC 103 without a CLEAN drug screen. All drug screens MUST be completed prior to Business Day. You must submit your receipt from the lab or the results from Castle Branch on Business Day, if you have received them.
Background Check Cost: \$80* to CVEMSA \$65* to LiveScan	Applications for Coastal Valley EMS Agency will be <u>completed in class</u> during Business Day. Fingerprinting will be <u>completed in class</u> on Business Day. The fees for applications and fingerprinting are due in class on Business Day, paid directly to the agency representatives.
Influenza (Flu vaccine)	Submit documentation of a flu shot administered during the current flu season (August-March). The vaccine Batch number is required.
Varicella (Chicken Pox)	One of the following is required, EITHER: <ul style="list-style-type: none"> - 2 vaccinations. If series in process, submit where you are in the series. - Positive antibody titer (lab report OR physician verification of results required). If titer is negative or equivocal, student must receive 1 booster shot. OR <ul style="list-style-type: none"> - Documentation from doctor's office (on letterhead) stating you have had chickenpox as a child and do not require the vaccination.
Measles, Mumps and Rubella (MMR)	One of the following is required, EITHER: <ul style="list-style-type: none"> - 2 vaccinations. If series in process, submit where you are in the series. - Positive antibody titer for all 3 components (labreport OR physician verification of results required). If titer is negative or equivocal, student must receive a booster vaccine.
Tetanus, Diphtheria & Pertussis (Tdap) (Tetanus shot)	Documentation of a Tdap booster administered within the past 10 years.
Hepatitis B	One of the following is required, EITHER: <ul style="list-style-type: none"> - 3 vaccinations. If series in process submit, where you are in the series. - Positive antibody titer (lab report or physician verification of results required). If titer is negative or equivocal, student must receive 1 booster shot.
TB Test (PPD)	One of the following is required, EITHER: <ul style="list-style-type: none"> - 2 Step TB Skin test within last 6 months. <u>This process requires 4 visits, one to administer the injection and one to receive the results (72 hours after the first appointment). Repeat process again within 1-3 weeks.</u> If positive results, provide a clear Chest X-ray or signed documentation from your doctor verifying you do not have TB. - QuantiFERON-TB Gold blood test results within last 6 months.
