COURSE DESCRIPTION

This course fulfills the requirements of Section 832 of the Penal Code as mandated by the California Commission on Peace Officer Standards and Training (POST) for agencies authorizing the use of firearms

Firearms topics covered are: care and maintenance, function, safety, shooting positions and fundamentals

*An accuracy test is required for successful course completion

REQUIRED EQUIPMENT

A pistol in good working order in 9mm, 38, 40 or 45 caliber, and 357 magnum. **No single action pistols are permitted without prior conversation with Training Center firearms instructors' approval. Approval must be given prior to the beginning of class. (Several weeks before).**

- Three magazines of the caliber of your weapon.
- A good sturdy belt capable of holding your pistol.

- A holster which will not close upon itself, we recommend Kydex or a brand name duty style leather holster
- A magazine pouch capable of holding two magazines
- If you are using a duty type holster, it should have a minimum of three keepers for your belt
- A cleaning kit containing: A cleaning rod, with bore brush or bore snake, bronze utility brush, nylon utility brush, bore solvent, gun oil or gun grease, and cleaning patches

AMMUNITION

500 Rounds lead free ammunition of the caliber must be brought the first day of class, in its original container. Only Training Center approved lead free ammunition will be allowed. Leadfree ammunition is in short supply and should be ordered well in advance of the class. Pursuant to California Penal Code section 25610, a United States citizen over 18 years of age who is not prohibited from firearms possession, and who resides or is temporarily in California, may transport by motor vehicle any handgun provided it is unloaded and locked in the vehicle's trunk or in a locked container. Furthermore, the handgun must be carried directly to or from any motor vehicle for any lawful purpose and, while being carried, must be contained within a locked container.

Pursuant to California Penal Code section 16850, the term "locked container" means a secure container that is fully enclosed and locked by a padlock, key lock, combination lock, or similar locking device. The includes the trunk of a motor vehicle but does not include the utility or glove compartment.
